

Marion Technical College – HEERF III / ARP Fund Declaration

In May 2021, Marion Technical College was granted \$1,876,160 in Higher Education Emergency Relief Funding (HEERF) III under the American Rescue Plan Act (ARP) to provide student emergency grants. To receive these grants be enrolled as a general at Marion Technical College.

HEERF III / ARP Fund Declaration Reporting

October 6, 2021

1. The institution received a total of \$1,876,160 for Emergency Financial Aid Grants to Students.
2. The institution has distributed a total of \$240,750 as of July 26, 2021.
3. A total of 460 enrolled students have been awarded a HEERF III (ARP) Emergency Financial Aid Grant as of July 26, 2021.
4. Marion Technical College used a sliding scale based on Expected Family Contributions (EFC) determined by FAFSA completion. Students received amounts from \$350 to \$750. Student who had not completed a FAFSA received \$350. All eligible students were notified by text of their eligibility and mailed checks.
5. In July 2021, all students were contacted by both, email and postcard, regarding possible opportunities for professional judgement adjustments if their income or family situation was affected by the pandemic.

January 3, 2022 Update

1. The institution received a total of \$1,876,160 for Emergency Financial Aid Grants to Students.
2. The institution has distributed 986 students an additional \$774,700 as of October 18, 2021.
3. For this disbursement Marion Technical College used a sliding scale based on Expected Family Contributions (EFC) determined by FAFSA completion. Students received amounts from \$600 to \$1,000. Student who had not completed a FAFSA received \$600. All eligible students were notified by text of their eligibility and mailed checks.
4. As of January 3, 2022 - 1,446 students have been awarded \$1,015,450 HEERF III (ARP) Emergency funds

March 29, 2022 Update

1. The institution received a total of \$1,876,160 for Emergency Financial Aid Grants to Students.
2. The institution has distributed 934 students an additional \$360,650 as of March 29, 2022
3. For this disbursement Marion Technical College used a sliding scale based on Expected Family Contributions (EFC) determined by FAFSA completion. Students received amounts from \$300 to \$500. Student who had not completed a FAFSA received \$300. All eligible students were notified by text of their eligibility and mailed checks.
4. As of March 29, 2022 – 2,380 students have been awarded \$1,376,100 HEERF III (ARP) Emergency funds
